FAQ's

What is the basis of the B Greenly Certificate?

All certificates are private, there are no public certificates. B Greenly is based on the main global bodies that are a reference in terms of sustainability, such as the Sustainable Development Goals (SDGs) and the 2030 Agenda, the United Nations Environment Programme (UNEP), the Global Reporting Initiative (GRI) methodology, the metrics of the World Economic Forum (WEF), various European Union (EU) Directives and Regulations, and any other relevant Standard in the field.

What is the methodology B Greenly?

B Greenly's working system is based on parameters and metrics derived from the main world bodies that are a reference in terms of sustainability. It is a fast and agile system that allows an event or venue to be certified anywhere in the world.

Can B Greenly help make an event, venue or company to be sustainable, without the need for certification?

Of course, B Greenly is supported through its Manual of Organisation and Good Practices for sustainable events, venues and companies.

FAQ's

Where can I find references for certified events, venues or corporate B Greenly?

Both on our website and on our social networks (Instagram and LinkedIn) there are specific references to events, venues or companies certified by B Greenly.

How long does a B Greenly certification last?

The B Greenly Certification for events is valid for the date of the event. In some cases, our clients organise several events during the year, in these situations a Certificate valid for the whole year is issued. On the other hand, the validity of the certification for a venue/corporate is for three years.

What is the cost of a B Greenly certificate?

B Greenly has annual rates, the cost of a B Greenly Certification will depend on the type of service contracted and the event, venue or company to be certified.

Can a natural person be B Greenly?

No, B Greenly certifies events, venues or companies, not people. A person can organise/direct an event, venue or company and B Greenly can certify them, but not the person.

FAQ's

Is there a specific type of event, venue or company in order to be certified by B Greenly certified?

B Greenly is dedicated to the certification of sustainable events, venues or companies of any size and type. The parameter lists and methodology are adapted to any kind of event, venue or company, regardless of size.

How do I make it known that the event, venue or company is B Greenly?

On our website and social media we publish all events, venues and companies certified by B Greenly. In addition, our clients publicise the awarding of the certification in their media, web and networks.

Can B Greenly Certification affect the quality, design, aesthetics, etc. of the event?

B Greenly certification helps to improve management processes, making them more efficient and, above all, more sustainable. Whenever there are some proposals, they are for improvements in the organisation.

I am an event, venue or company B Greenly, what now?

First of all, congratulations, this means that the event, venue or company is sustainable. From this moment on, we will be improving areas and parameters so that each year the level of sustainability increases. Sustainability is a long road that requires will, time and perseverance.
